# Midas Export USA Corp. Product Warranty Statement

**This is a Sample**

Midas Export USA Corp. warrants their window film products (manufactured in USA) covered by this original agreement against crazing, peeling, cracking, demetallizing, bubbling, delaminating or adhesive failure under normal use on interior glass surfaces for a limited period after installation date for the following products: Titanium Neutral PS/DS; Sapphire DS/PS Series; Silver DS/Silver HP; Alaska Series; HPX; Matrix; Solar Ice DS/PS; Solarglaze DS/PS; Gelid; SolarBronze, Omega.

All these product lines are associated with the following warranty period:

**Lifetime** when installed on interior glass surfaces to the original consumer as long as they own and live in the home or **ten (10) years** when installed on interior glass surfaces of an occupied commercial building.

If the film fails to comply with the product warranty coverage, Midas Export USA Corp. will furnish replacement film (labor and materials) for any of the film covered by this original agreement at no cost to the customer. Midas Export USA Corp. assumes no liability for damage to film from abuse or improper care or treatment, improper film installation, improper film-to-glass application, glass breakage or IG unit seal failure. Midas Export USA Corp. requires that the customer retain this original agreement and the invoice relating to the film installation. Proof of purchase is required to obtain coverage.

### Warranty Disclaimer

Midas Export USA Corp. hereby disclaims liability for any incidental, special, consequential or punitive damages arising from any defect in the product covered by this warranty. Except during the applicable limited warranty period set forth above, Midas Export USA Corp. hereby excludes and disclaims any and all other express or implied warranties, including the warranties of merchantability and fitness for particular purpose. No contractor, including any other Midas Window Film™ dealer or distributor, has any authority or power to modify or extend the limited warranty of the manufacturer contained in this original agreement. This limited warranty gives you specific legal rights and you may also have other rights that vary from state to state. Some states do not allow this exclusion or limitation of accidental or consequential damages or limitations on how long an implied warranty last so that above limitations and/or exclusions may not apply to you.

This original agreement or any part of it is void where prohibited by law. This limited warranty shall NOT apply when: (a) Dealer or Installer is not authorized by Midas Export USA ; (b) dealer's installation does not conform to the manufacturer's regulation and procedures; or (c) more than one film to any window or partial application of film to glass; or (d) the windows are of triple pane construction, double pane glass with suspended films, textured, laminated, patterned reflective, or wired glass; or (e) applied to any glass on which there is paint, lettering, stickers or other ornamentation; or (f) on glass which is visibly damaged, chipped, cracked or pierced or has holes in it where light can be seen between glass and frame; or (g) applied to plastics, acrylics, polycarbonates or non-glass substrates.

### Window Film Care Instruction:

- Do not wash film for thirty (30) days
- When cleaning, do not use materials with hard abrasives or hard brushes. Use only a soft cloth and mild detergent solution. You may use a squeegee for drying window.
- After installation there may be a hazy appearance or small water beads until all moisture has dried.
